Education: DriveKind RideKind (DKRK) is a program developed by Please BE KIND to Cyclists (Please BE KIND) under a grant with the Texas Department of Transportation (TxDOT) to promote safe driving practices by motorists as they share Texas roads with vulnerable road users such as cyclists and pedestrians. The program is specifically created for driver education instruction and schools, defensive driving classes, commercial driving schools, law enforcement academies in Texas, as well as the general public. During 2014, development was underway of a 15 minute educational video, a Program Guide (booklet which explains how to teach the video to target audiences), a welcome letter, Public Information & Educational Materials, a marketing package for mailing and distribution plus a dedicated website (www.DriveKindRideKind.org) where all educational materials will be housed. The first year grant with TxDOT was effective January 15, 2014 through September 30, 2014; however, a second year application was submitted and approved for funding which was effective October 1, 2014 and runs through September 30, 2015. DKRK was launched mid-2015. Volunteer hours during 2014 were estimated to be over 717 hours. In-kind services totaled \$91,042. Cyclists VIP is a program that teaches the law of common sense while riding a bicycle. The acronym VIP stands for Visible, In the Moment, (Continued on Schedule O, Statement 1)

Public Awareness: A major accomplishment in 2014 was the Safe Passing Public Awareness Campaign where proprietary graphics were installed in the back of 20 transit buses depicting the "Safe Passing Ordinance" (Cars must give 3' and commercial vehicles 6', when passing a cyclists) during the months of May and June. Capital Metropolitan Transportation buses traveled throughout the Austin area educating the general public of this law which has been in existence since 2011. It was estimated that the message received over 2 million views during those two months. Volunteer hours were estimated to be over 200 hours with In-kind Advertising & services at \$4,620. Please BE KIND to Cyclists continued to provide printed materials such as banners, bumper stickers, t-shirts, jerseys, flyers, etc. with the message "Please BE KIND to Cyclists". This message is key to motivating a global social change in the behaviors of motorists and cyclists so both use the road safely and with mutual respect resulting in healthier, more harmonious communities. In 2014 Please BE KIND attended and distributed educational materials at local events such as Viva Streets, Austin Bike to Work Day, Rally for Respect, Shiner GASP 2014, Bike Austin Summit, Bike Month Wrap Party, Austin Bike Fest, Brownsville Siclobia, Please BE KIND Fall Classic Ride, and others.

Tragedy Assistance Program provides a support system for families and cyclists that suffered injuries from crashes with motor vehicles. Victims of cycling crashes benefited from Patient Advocate Services, Legal Advocate Services and Fundraising events. Please BE KIND worked with family members and friends to organize memorial rides and create "Ghost Bike" memorials at crash sites. The Ghost Bikes help raise awareness and remind all road users that a life was lost at the site. Benefit events to help injured cyclists were held throughout the year via Go Fund Me accounts created and shared via Social Media to provide financial assistance to victims and their families. Volunteers contributed over 300 hours during 2014. Over \$4,500 in-kind services directly benefited individuals in 2014.

and Predictable. Cyclists are reminded to use proper lighting and clothing to make themselves visible at all times. In the Moment is explained as being fully engaged in the act of riding a bicycle and being aware of one's surrounding when riding in traffic. Lastly, cyclists are asked to be Predictable by using hand signals to alert other road users of their intentions (turning or stopping) and to follow the rules of the road. When cyclists engage in these three areas, they are one step closer to preventing crashes with other vehicular traffic on the roads. In 2014, Please BE KIND presented to students, business leaders and other cycling groups at events such as the Austin Traffic Safety Symposium, WholeFoods wellness expo, CSID Wellness Expo and others. Volunteer hours were estimated to be over 150 hours in 2014 for this program.
