Education: DriveKind RideKind (DKRK) is a program jointly developed by Please BE KIND to Cyclists and the Texas Department of Transportation (TxDOT) to promote safe driving practices by motorists as they share Texas roads with vulnerable road users such as cyclists and pedestrians. DKRK is designed to change behaviors in order to decrease cyclist and pedestrian crashes and fatalities. The DKRK educational video and instructional materials were developed for use in driver education instruction and schools, defensive driving classes, commercial driving schools, law enforcement academies in Texas, and for viewing by the general public. 2015 saw the launch of the program which is composed of an educational video, ten (10) Public Service Announcements (PSA's), a website, a Program Guide, blogs, social media outreach, and print materials. Accomplishments for DKRK include: 15 minute video launched May 26, 2015. PSA's launched September 22, 2015. YouTube lifetime analytics include 3,935 video views and 621 PSA views through December 31, 2015. Please BE KIND has presented and distributed over 2,000 Welcome Packets that included DKRK video and educational materials to driver education instructors, commercial driving instructors, law enforcement, transit professionals, city bicycle /pedestrian coordinators and other interested parties at traffic safety

Public Awareness: The campaign "Rally for Safe Roads" is a visual representation of the Safe Passing and Hands-Free laws which are displayed on outdoor media, and Cyclists V.I.P., which educates cyclists on best practices while riding. These graphics have been instrumental in educating citizens about the shared responsibility of roadway use. In 2015, we had these 3 messages installed in the back of 30 Capital Metro buses during the months of May and June. Transit buses traveled throughout the Austin area educating the general public on shared roadway use among drivers and vulnerable users, particularly cyclists. It was estimated that the message received over 5 million views during the two months. Volunteer hours 150 In-Kind Advertising & services \$10,012 Please BE KIND to Cyclists (Please BE KIND) provides printed materials such as banners, bumper stickers, t-shirts, jerseys, flyers, etc. with the message "Please BE KIND to Cyclists". This message is key to motivating a global social change in the behaviors of motorists and cyclists so both use the road safely and with mutual respect resulting in healthier, more harmonious communities. Please BE KIND tabled at events such as Austin Bike Fest, Bikes vs. Cars screening, Statewide Motorcycle Safety Forum, National Safety Council 2015 Community Safety Summit, Shiner Ride, Impaired Driving Forum, Bike to

Tragedy Assistance Program provides a support system for families and cyclists that suffered injuries from crashes with motor vehicles. Victims of cycling crashes benefited from Patient Advocate Services, Legal Advocate Services and Fundraising events. Please BE KIND worked with family members and friends to organize memorial rides and create "Ghost Bike" memorials at crash sites. The Ghost Bikes help raise awareness and remind all road users that a life was lost at the site. Benefit events to help injured cyclists were held throughout the year via Go Fund Me accounts created and shared via Social Media to provide financial assistance to victims and their families. On March 21, 2015, Please BE KIND to Cyclists installed a permanent memorial to provide a place for anyone to gather and show respect for the four people that were killed by a driver fleeing police on March 13, 2014 that occurred during the SXSW Music Festival. Hatch Workshop donated a white obelisk, that is slightly over six feet high. It stands in the shade beneath an oak and a mountain laurel, at a grassy patch. Affixed to it is a plaque with the names of the people killed in the horrific crash. Please BE KIND to Cyclists honors the victims in memoriam, and invites its members to reflect on the
